

APPLICANTS FOR FORMALDEHYDE PEC ASSESSMENT

Formaldehyde was declared a Priority Existing Chemical (PEC) by the Minister for Health and Ageing on the 5th March 2002. In accordance with the *Industrial Chemicals (Notification and Assessment) Act 1989*, as amended, all those who wish to manufacture or import formaldehyde during the period that formaldehyde is a PEC must apply in writing using the PEC Application Form. Importers of products/mixtures containing formaldehyde must also apply for assessment. Persons other than importers or manufacturers may also apply. There are no application fees.
