- ii) Modular Applications- previously assessed by TGA, APVMA or FSANZ.
- iii) Modular Applications- similar to chemical previously assessed by NICNAS.

Modular – Secondary Chemical fee is applicable if a second chemical is being notified at the same time as a similar chemical (primary chemical) and for a similar use- NICNAS may remit part of the regular fee.

*** Approved Foreign Scheme – Canada- **only** applies for applications that are made in Canada under a comparable schedule (please contact NICNAS for guidance on the use of this category).
